#### Remarks:

On 23 March 2023, a total of 187,265,918 Class A Convertible Preference Shares and 187,265,918 Class B Convertible Preference Shares have been allotted and issued by the Company to DYZH Holdings Limited in accordance with the terms and conditions of the Subscription Agreement. At any time during the 30-month period beginning on the first anniversary of Completion, each Convertible Preference Share may be converted into Conversion Shares as equal to the quotient of the Subscription Price divided by the then effective conversion price, resulting in an initial conversion ratio of 1:1 for each Convertible Preference Share. As a result of the Share Consolidation which became effective on 29 July 2024, every forty (40) Existing Class A Convertible Preference Shares were consolidated into one (1) Consolidated Class A Convertible Preference Share and every forty (40) Existing Class B Convertible Preference Shares were consolidated into one (1) Consolidated Class B Convertible Preference Share of par value of HK\$0.4 each in the share capital of the Company. A maximum number of 12,191,977 Ordinary Shares shall be allotted and issued upon full conversion of all the Convertible Preference Shares, which is being calculated based on the assumption that (i) each Convertible Preference Share is being converted into one Conversion Share; and (ii) the Conversion Price for Class A Convertible Preference Shares and Class B Convertible Preference Shares is HK\$15.44 and HK\$21.44, respectively.
